The adjacent neighbour at number 6 Bretts Cottages, Mrs Wilson, asked her son-in-law to read out a letter of objection to the proposals. The Clerk had been asked to read out a letter from the applicant. Following discussion the Committee agreed to support the two sets of amended plans which seem to have addressed many of the earlier issues. However they have noted that the neighbours still have concerns and understand that the sunlight issue is still to be resolved.

 WD/2011/0646/F – Construction of manage and surrounding post and rail fence.

Springfield, Etchingwood Lane, Framfield TN22 5SA.

The PC supports the application providing the facilities are for provide use only.

- WD/2011/0645/F Construction of agricultural barn.
   Springfield, Etchingwood Lane, Framfield TN22 5SA.
   The PC supports the application which they believe is a relatively modest proposal for the site.
- 7. WD/2011/0600/F Demolition of existing dwelling and construction of replacement dwelling with new access road. Construction of a new agricultural barn and the conversion of existing barn into a two bedroom holiday let.

  Orchard Farm, Scaines Hill, Blackboys TN22 5JL.

  The PC wishes noted that they have no objection to a replacement dwelling in principle. However they do object to this application. They believe that it is an unusual design for the area which struggles to compliment the countryside in which it is located.

   Hiders Farm, Pump Lane, Framfield TN22 5RQ.
   The PC supports this third application as they have done the previous two. The new conservatory will replace the current one and enhance this Listed Building.

   Tickerage Castle, Pound Lane, Blackboys TN22 5RT
   The PC again supports this application it will enhance the Listed Building.
- WD/2011/0507/LB Repair/strengthen crack damage as a result of subsidence damage/movement.
   1 Framfield Place, Hammonds Green, Framfield TN22 5QH
   The PC supports the application but would defer any final decision to the Conservation Department.
- WD/2011/0818/MAJ Enlargement of existing sand school, demolition of existing and erection of new bungalow and garage, erection of implement/storage barn together with dependent works and landscaping.

  Placehouse Study Change Lange Blackhouse TN22.51.5.

Blackboys Stud, Chapel Lane, Blackboys TN22 5LS.

The PC objects to this application. They still believe that it is massive over-development of a small rural site down a narrow country lane. The lane would be subject to an unacceptable increase in traffic detrimental to other residents - the sheer size of the proposal must mean that this would be a commercial enterprise and vehicles associated with horses are in addition large and difficult to handle.

The PC hopes that the works that appear to have been carried out to the land are being investigated by WDC.
