The applicant and an adjacent neighbour were in attendance. The applicant gave a brief verbal presentation on the application and the adjacent neighbour voiced his objections on the grounds of the scale of the building with particular relevance to height and size in comparison to the adjacent properties.

The Parish Council supported the idea in principle for a replacement dwelling on the site. However, they commented that the quality of the plans make it very difficult to see exactly what the size, position and impact on the adjacent properties will be.

• WD/2014/1758/FR – Extension to garage permitted by WD/2008/1415/F – (retrospective), external staircase, rooflights and use of roof space of garage as ancillary living accommodation.
