Minutes of the Meeting of Framfield Parish Council (PC) held at the Village Hall, Blackboys, on Tuesday, 28 January 2025 at 6 pm.

(The minutes are detailed in the order in which they appeared on the agenda but not necessarily the order in which they were taken at the meeting).

Councillor Chris Dowling (ESCC) made the following report:

Highways-related matters:

- Chris is meeting with the ESCC Highways Steward with the Chairman later that week to inspect some of the 'hot spots' in the Parish.
- Hammond Green the line painting is scheduled in for 7 February 2025.
- John Dann Close ESCC Enforcement are dealing with the unauthorised signage.
- Building site adjacent to Blackboys recreation ground the issue with deliberate pumped water run-off will
 be highlighted to the Highways Steward. The Chairman stated that WDC seemed to have washed their
 hands of the site water run-off and accumulation of rubbish.
- Lewes Road, Blackboys CMF to reduce the speed limit between Hollow Lane and Brownings Farm the works are scheduled to be carried out between 3 and 29 March 2025. It is thought that any works associated with the Route Survey Work in the same area will be done at the same time.
- AFC Uckfield Chris is endeavouring to meet with the Club Manager to discuss the on-street car parking issues when there is a match.
- Bird-in-Eye Hill there was another road traffic accident in recent days. The Chairman commented at what point does ESCC look at accident black spots in more depth with particular relevance to the number of accidents on the B2102 at Pound Hill in recent weeks.

Chris stated it is budget time and there is very likely to be an increase in Council Tax with a cut in services.

Councillor Ann Newton (WDC) reported on:

- Council Tax over the Christmas period some residents' Council Tax was taken earlier than it should have been. Residents should contact WDC if any have incurred bank charges etc. An investigation has been held into the reasons that it happened and a review is under way around the lack of communication on the issue.
- Public Inquiry Ann at attended that day an Inquiry instigated by a developer wishing to remove two
 conditions on a planning approval restricting occupation until the mains sewer is connected. A very
 important case for the District.
- Devolution Ann had furnished all councillors with an explanation on what was happening to date. The
 decision from Government will be known shortly.

2. Declarations of Interest

4. Matters Arising from the Minutes

- Parish Streetlighting update. The new company have already carried out some of the simpler repairs
 and an inventory of the lights has been drawn up. It is expected any links with ESCC will be severed
 shortly in the New Year when a new energy supplier has been sourced.
- Step Up Sports update. The Clerk was asked to circulate the survey which Trishia has kindly edited.
- John Dann Close signage update. The issue is with ESCC Enforcement.

5. Devolution

Brief discussion revolved around if parish/town councils would be given more responsibilities and funding. A copy of the note on devolution has also been placed in the Parish Magazine.

6. Correspondence received since the last meeting

Letters for noting/discussion (Including items that have been received after this agenda has been published) – most items were from pending matters and dealt with under separate headings.

- WDC: Wealden Electoral Review January consultation postponed until the decision on the devolution White Paper is known.
- ESCC: East Sussex Rights of Way Access Plan to be passed to David Jenner.

7. Finance and General Purposes:

- a) Resolve to purchase two new laptops, one for the Parish Clerk and RFO sufficient funds are within the 2024/25 budget. The meeting agreed the expenditure (TB/DJ).
- b) Chairman/Clerk to be given the authority to change the Parish telephone line/internet to provide a more value for money service. Councillors agreed the proposal (KB/TB).
- c) Ratification of the decision to increase the Parish Clerk's and RFO's salaries in line with the NALC recommendations for 2024/25 from 1 April 2024. Email sent to the Chairman of NALC (a response is awaited). Councillors agreed the ratification (KB/TB).
- d) Agree to proceed to .gov.uk domains for website and email. The Chairman explained that this wasn't currently mandatory but could become so. The meeting agreed to wait to see what happens at the current time.
- e) Bank reconciliation, balances and accounts all Councillors were in receipt of a copy of the financial sheets for comparison and agreement. The accounts were verified as correct by the Council. (DJ/TB).
- f) Resolve to agree the payments/disbursements since the November meeting as detailed on the report as circulated. These were agreed and detailed at the end of the minutes. These were agreed (DJ/TB).
- g) Any other financial/general purposes matters:
 - Sandy Lane reflective posts/bollards. The meeting agreed that these would be a good idea but asked the Clerk to contact ESCC regarding the potential and costings.
 - Beechy Road/Hollow Lane passing places. Councillors agreed that all the passing places should be removed with the possibility of one being kept below Brinkburn just before the corner which does allow oncoming traffic a safe area to move over.

8. Planning Committee.

- The minutes/delegated comments since the last Parish Council meeting were agreed as read.
- Land South of Framfield Road, Blackboys. Ground works are underway.
- Land at the Old Nursery House, Framfield. The PC's comments have been sent into WDC.
- Land North of the Eastbourne Road, Framfield (Cysleys Farm). Following on from the refusal of the original application by WDC Committee, an identical application has been submitted by the applicant due to inconsistencies of approach by ESCC on their application and to one on a nearby site which has been approved. Comments from the PC have been sent onto WDC.
- Notice of Appeal WD/2024/1799/MAO: Bird in Eye Farm, South of Bird-in-Eye Hill. The applicant is appealing for non-determination (validation) of the application and comments from the Parish Council have been sent onto WDC.
