Minutes of the Meeting of Framfield Parish Council (PC) held at the Village Hall, Blackboys, on Tuesday, 29 July 2025 at 6 pm.

Three residents were welcomed to the meeting and it is hoped that they will join the PC in September. Clerk to get in touch.

Councillor Ann Newton (WDC) reported on:

- Devolution Ann reported that the next timeline for a decision was September on how the unitary authorities would be formed in Sussex.
- An allocation of £10k per Ward Councillor has been allocated for local projects. The devil will be in the detail but cannot be allocated to parish council expenditure.

1. Apologies for Absence

Councillors Chris Dowling (ESCC) and Linda Jenner.

The Chairman commented on the sad passing of Jeff Goggin, his predecessor as Chairman of the Parish Council.

2. Declarations of Interest

Councillors to give notice of declarations of personal, prejudicial and pecuniary interests in respect of items on the agenda. There were none.

3. To accept the Minutes of the last meeting (27 May 2025 [the AGM])

It was resolved to accept the minutes of the meeting held on 27 May 2025, having been circulated, as a true and accurate record as proposed by Keith Brandon and seconded by Trishia Blewitt.

4. Matters Arising from the Minutes (25 March 2025)

All other items are included elsewhere in the minutes.

- Parish Streetlighting update. The Chairman reported that a survey report has been completed but only details items associated with electrical maintenance so a query has been raised as to the need for a full structural report. The supply of energy has been more problematic as the amount of energy currently used seems to be unknown meaning that energy is still supplied by ESCC.
- Step Up Sports update. Councillors agreed that the survey should be sent out but that a meeting should be held with the contact who has assisted in getting this off the ground. TB and DJ to attend along with the Chairman Clerk to source dates.
- Parish Magazine the Clerk confirmed that the Vicar (and Parochial Church Council) have agreed to remove Fernley Park from the distribution list to enable some flexibility as and when new households come live within the civic Parish.

5. Correspondence received since the last meeting

- WDC: Street Naming & Numbering SNN1884D Development at land adjacent to Recreation Ground at Blackboys. The meeting agreed that the name should be Post Mill Close in recognition of the post mill which was on the site.
- ESCC: Temporary Traffic Road Safety Signs. Chairman to write to Councillor Dowling voicing his
 displeasure at the decision which brings the responsibility and expense to the Parish Council of
 installing any such signs.
- Kent, Surrey Sussex Air Ambulance Charity letter of thanks.

6. Finance and General Purposes:

- a) The meeting resolved to increase the budget to allow for up to £1,000 of donations to be made in the financial year (DJ/TB).
- b) Councillors resolved to transfer £85,000 into the Redwood savings account (TB/MN).
- c) The meeting agreed to purchase two new cabinets for the AED's situated at both halls to be paid for out of CIL (KB/MN). The Clerk to look at potential training courses.
- d) Councillors resolved to agree to the renewal of the Parish Council insurance policy an increase of approximately £200.00 on the previous year (TB/DJ).
- e) Bank reconciliation, balances and accounts all Councillors were in receipt of a copy of the financial sheets for comparison and agreement. The accounts were verified as correct by the Council. (DJ/TB).
- f) Resolve to agree the payments/disbursements since the March meeting as detailed on the report as circulated. These were agreed and detailed at the end of the minutes. These were agreed (DJ/TB).
- g) Any other financial/general purposes matters:
 - Resolve to agree to follow the usual procedure and tender process for the three-year grounds maintenance contract. This was agreed with some minor alterations to the documentation.
 - Litter bins review of the number of litter bins and resolve to request that WDC empty them. This was agreed (MN/KB).

7. Planning Committee.

- The minutes/delegated comments since the last Parish Council meeting were agreed as read.
- Notice of Appeal WD/2024/1799/MAO: Bird in Eye Farm, South of Bird-in-Eye Hill. The Clerk attended two days out of the four-day hearing. The decision very much relies on the opinion of the Inspector on the heritage points. [Post meeting note – the appeal was Allowed].

8. Verbal Reports/updates from Council Members and the Clerk (if required).

- Lewes Road, Blackboys update on CMF(Community Match Funding)/ Route Survey Work the Chairman reported that it still wasn't terribly clear on what was happening or when. It was thought that week commencing 18 August 2025 road markings and signs would be installed but not used until the legal process had been completed. The cost to the Parish Council has been confirmed as capped at £30k.
- High Street, Blackboys update on discussions to lower the speed limit to 30-mph. ESCC have informed the PC that CMF is no longer available. Confirmation that a feasibility study needs to be carried out at the cost of £500.00. A meeting would be looked at.

Clerk – report on any other items not recorded elsewhere in the agenda: *including details contained in a report from Councillor Chris Dowling (ESCC):*

- Footpath between Framfield and Blackboys despite continuing to chase, he is between departments.
- Palehouse Common traffic and speed limit issues raised by residents and is in contact with the relevant ESCC officers.
- The matters of devolution and local government/re-organisation are ongoing and there is a cross-party committee of councillors checking and commenting on matters.
- Uckfield High Street outside the Maiden's Head WDC are working with a contractor to change the
 current scaffolding to a 'bird cage' design which should allow the road to be re-opened and restored
 to the usual two-way traffic hopefully by the second week of August.

- Cluster meetings WDC Planning/Local Plan (Chairman/Clerk) 19 March 2025. Notes have been distributed.
