 WD/2024/1409/MAJ – Creation of 5 No. ponds and associated works as part of a habitat bank.

The Parish Council supports the application in principle, as the proposal to introduce a habitat-friendly area would offer clear ecological benefits. However, the PC has two key concerns that they believe should be addressed:

1. Quantity and Validity of Biodiversity Credits

There is no reference to the quantity of biodiversity credits that will be generated and made available to developers from this site. This raises concerns, particularly if a relatively small site were to be used to justify excessive development in other areas.

Has the site been assessed using the statutory biodiversity metric to ensure compliance with regulatory requirements?

The proposal highlights the creation of ponds, but the site is already a biodiverse area. Therefore, it is likely to be classified as low-to-medium tier for biodiversity enhancements. Simply adding ponds seems a relatively limited enhancement compared to the broader range of improvements that could be made.

2. High Spatial Priority for Woodland

This location is identified as a High Spatial Priority area for woodland development. If the intention is to convert the area into ponds, has an Environmental Impact Assessment (EIA) been carried out to assess the potential consequences of this change? Woodland creation has significant long-term benefits, and it is important to consider these in comparison with the proposed alterations.
